Candace Rogers shared:

- The school events that have taken place.
- KIPP Detroit Imani Academy new facility milestone schedule.
 - Target opening August 2027 (Phase 1=the K-8 will be built).
 - The facility can occupy 1,300 students.
 - One grade added per school year.
 - A photographer guides a drone over the facility every week. Footage will be on the website.
- MAP & DIBELS testing taking place this week.
- Chery Daniel and the Friends of Joide [group] donated \$500; funds were used to purchase \$100 that was distributed among five families at KIPP Detroit Imani Academy.
- Michigan Department of Education denied [credentialing] appeal.

Marleen Williams shared:

- Students attending school with 90% attendance is currently at 69%.
- Attendance percentage for Year- to-Date (YTD) is 88% as of Friday, January 9th.
- Chronically Absent to date is at 10%.
- Enrollment is currently at 128.
- Open Enrollment period is now taking place December 1-January 29th.
- Intent to Return(ITR) began on January 6th.
